

AWARENESS

1 in 5 people living with diabetes do not know that they have diabetes. Early detection and awareness is the first step to preventing complications from diabetes. Awareness includes understanding the diagnosis of diabetes and how it impacts overall health.

ACTIVATION

— Once the person living with diabetes is more aware of the disease, it is important for them to understand and take the steps toward optimal health. These include conversations and self-reflection to understand how diabetes impacts aspects that are meaningful to the person. This allows the person to identify powerful motivators for change.

ACCESS

-Once awareness and activation are achieved, having equitable and person-centered access to care is vital to best equip each person with the right care, by the right person, and at the right time. Ensuring access to care that meets their needs can help the person living with diabetes to implement the decision-making and problem solving skills when needed.

Program Benefits

- Improved access to care by bringing all resources to the employee, which we anticipate will improve engagement.
- Cost avoidance due to employees being away from work for multiple appointments each year can add up to 45 hours per year for appointments, plus as many as 5 sick days related to illness.
- Coordinated care leading to improved outcomes over time will reduce overall cost of care for employees living with diabetes on your health plan.

How it Works

- Our clinical team will work with your insurance broker or third party administrator to identify all employees with diabetes on your health plan who would benefit most from participating.
- An introduction of the program and invitation to participate will be sent to identified employees.
- Our multidisciplinary team will schedule quarterly visits with these employees, bringing services directly to them.
- Program cost is \$300/employee/quarter, which includes services rendered on day 1 and 2 and appropriate follow-up to ensure the employee's success in the program. Program costs can be invoiced and paid by your health plan, replacing the individual claims for each service. Without multiple visit co-pays, employees have incentive to participate!
